OUR HISTORY

In February of 1971 Burnaby Family Life (BFL) enthusiastically opened its doors with the purpose of supporting families going through different challenges in life and had a vision of becoming a place where people can thrive, and families get stronger.

The organization was founded by Burnaby residents, members of the Burnaby business community, representatives of the social services sector, and Health and Education Ministries. At the time, there was also a need to support immigrating and struggling families facing new challenges, including lack of connection to resources for integration and settlement, poverty, and absence of gathering places where young families could grow their networks. Today nearly half of the individuals and families BFL serves are new to Canada with only 30% of them having English as a first language.

BFL's commitment to serving families and those in our community endures as we continue offering lifechanging programs and services that foster a sense of belonging for all. On average, BFL serves approximately 3000 clients each year, aiming to provide quality services and opportunities for families and individuals in all their diversity. We are committed to enhance growth and development by providing child care in six licensed centres, parenting support classes, individual support groups, family drop-ins programs, pregnancy outreach programs, family life education programs and counselling for women and children who have experienced trauma and abuse in safe, non-judgmental individual and group settings, where children and families can acquire the skills, they need to foster healthy families and communities.

BFL's programs and services includes of more than 20+ seasonal and on-going offerings (some delivered in languages other than English) that provide parents, caregivers, and children opportunities to develop knowledge to connect families and grow networks. Our programs promote healthy family life through confident parenting.

ABOUT THE BOARD OF DIRECTORS

Reflective of the values and beliefs of the organization, our board represents many sectors, and various definitions of families. We believe that a diverse range of leaders within the board allows for diversity of viewpoints that come from different life experiences and cultural backgrounds that strengthen board deliberations and decision-making.

The organization bylaws outline eligibility criteria for Board members are as follows:

- Each Director must be a member both at the time of their election or appointment and throughout their term of office.
- Ideally Directors will strive to possess two or more of the qualities outlined in the Specific Skills and Experiences on page 7.
- The Board should reflect a diversity of skill, experience, profession, age, race, gender and ethnicity

Directors will be nominated at the Annual General Meeting (AGM) and elected by the Board of Directors.

BOARD COMMITMENT AND REQUIREMENTS

- Willingness to govern by the established policy of the Board
- Ability to contribute to the diversity of input to the Board's deliberations
- Willingness to form linkages with other boards and community for the purposes of fulfilling Burnaby Family Life's goals and objectives
- A commitment to attend up to 10 meetings a year in Burnaby and to be available via electronic media (telephone, fax or email)
- Maintain membership in Burnaby Family Life- see page 8
- Aligned Burnaby Family Life's Vision and Mission
- Willingness to join board committees as needed
- Willingness to bring information and ideas to the Board

TERMS

Terms are two consecutive years. Directors may serve three consecutive terms.

EXPENSES

The Directors of the Burnaby Family Life shall serve without remuneration and the Directors shall not receive directly or indirectly, any profits from their positions as Directors, but will be reimbursed for all paid expenses incurred by them in the performance of their duties.

BOARD NOMINATIONS AND ELECTION

People who wish to stand for nomination to the Board must complete the nomination application.

The Nominating and Governance Committee will recommend a list of potential Board Directors to the Burnaby Family Life Board for their information and approval.

The Nominations and Governance Committee will present new nominees to the Burnaby Family Life membership at the AGM in September; however, new Board members may be invited to join at any time throughout the year if the board deems it necessary. Because Burnaby Family Life serves vulnerable clients, all applications to become a Board Member must go through a Criminal Record Check. Please note that this does not need to get done until you have had your formal interview with the Nominations and Governance Committee.

BASIC PRINCIPLES OF POLICY GOVERNANCE

THE POLICY GOVERNANCE® GOVERNING STYLE

- Outward vision rather than an internal preoccupation
- Encouragement of diversity of viewpoints
- Strategic leadership more than administrative detail
- Collective rather than individual decisions
- Future rather than past or present
- Proactivity rather than reactivity

POLICY GOVERNANCE® PRINCIPLES

- 1. Governance is a function of ownership, not of management.
- 2. The board is the link in the chain of command between the ownership and management.
- 3. Board authority is group authority.
- 4. Ends policies prescribe organizational results, beneficiaries, and worth.
- 5. Governance Means Policies describe the board's methods and self-discipline.
- 6. Executive Limitations Policies set boundaries of prudence and ethics.
- 7. Policies are developed in steps from broadest to smallest.
- 8. Delegations are unambiguously assigned.
- 9. Delegates may use any reasonable interpretation of policies.
- 10. Regular monitoring again policy criteria is conducted.
